2025 SNF 3-Day Rule Waiver Program: SNF Participation Guidance

Thank you for your ongoing partnership with the MercyOne Population Health Services Organization (PHSO)! Your facility is contracted with us to participate in our MSSP SNF 3-Day Waiver Program for calendar year 2025.

What is the Skilled Nursing Facility (SNF) 3-Day Rule Waiver?

For eligible patients and SNFs participating in Medicare Shared Savings Program (MSSP), CMS will waive the three midnight inpatient hospital stay requirement prior to a Medicare covered SNF admission.

Patient Eligibility Criteria

<u>All</u> of the following criteria must be met, in order for the 3-Day Rule Waiver to apply:

- Patient must be currently assigned (attributed) to one of MercyOne's Enhanced MSSP programs
- Patient was directly evaluated by a MD, DO, PA, NP, or CNS who is employed by an organization participating in the same MSSP program as the patient
- · Patient is medically stable
- Patient has a certain and confirmed diagnosis
- Patient has identified skilled nursing or rehabilitation need that they cannot receive as an outpatient
- Patient does not reside in a long-term care (LTC) facility

SNF partners can expect a signed 3 Day Rule Waiver Form verifying that the patient and provider are meeting CMS requirements.

SNF Expectations

- SNF must have and maintain an overall rating of 3 out of 5 stars on CMS 5-star Quality Rating System. Dropping below 3 stars will result in a probationary process and possible removal from the program by CMS.
- SNF must be continuously enrolled in Medicare
- SNF is required to add demonstration code 77 in "treatment authorization" field on claim
- It is the responsibility of the SNF to resolve any billing issues

Tips for Facilities

- The waiver does not create a new benefit or expand Medicare SNF coverage
- The waiver does not restrict the patient's freedom of choice for provider or supplier
- CMS defines 3 days as 3 full calendar days (i.e., 3 midnights have passed)
- Please notify us immediately of any upcoming ownership, Tax ID or legal business name changes – any entity change will invalidate your eligibility to use the 3-Day Rule Waiver
- The PHSO post-acute coaches are available to collaborate with the facility and provide care management and care coordination services for attributed patients, and can assisted with discharge planning.
